The vision of KHNM is to glorify God through the redemption of our neighbors in prison by the gospel of Jesus Christ and their continued discipleship out of prison, thus reducing the recidivism rate. Our mission is to bridge the gap between the Christian inmate and the local church by facilitating the integration of the former inmate into the church, workplace, and society through biblical discipleship.

MEET ME AT THE GATE: Since 1997, KHNM has worked with churches, organizations, and individuals in ministering to Christian neighbors coming out of prison for whom no family-home-based program is available. Since 2008, it has worked through its affiliate, Koinonia House of Wheaton (KHW), to provide Christian men coming from prison a residential family-home-based discipleship program. In 2020, KHW temporarily suspended its residential ministry to men and provided housing to two females who have been incarcerated. In addition, KHNM/KHW assisted nine individuals with re-entry issues. Although the COVID-19 pandemic halted our ability to meet in-person for much of 2020, Radical Time Out (RTO) never missed a meeting. Using videoconferencing technology, RTO continued to be a vehicle of blessing as an average of 56 people met weekly for prayer, Bible study and the opportunity to experience the love and grace of Jesus Christ, regardless of color, class, culture, crisis or crime. A highlight was welcoming home Kathy, a former regular at RTO, after she completed five years of prison. The RTO community commissioned Kathy to be its missionary behind bars before she left. Kathy conducted Bible studies and mentored women in each of the three facilities where she served her time. She said, "RTO is family . . . and provided Bible studies and books. I couldn't have gotten through those years without them."

BUILDING BRIDGES, RESTORING HOPE: Expenses cover activities such as helping families of incarcerated individuals, educating the public on the needs of people returning to society from prison, and ministering to donor families. This was especially important when prisons went on lockdown due to the pandemic and communication with incarcerated loved ones became more difficult. In 2020, KHNM staff ministered to 45 individuals/families in formal and informal settings. KHNM staff also spoke/taught at 14 services in 7 churches and 4 organizations, a podcast program, and a Spanish radio program. A 2020 highlight was working with individuals from a local church to help them establish a residential family-home-based discipleship program for men. KHNM staff assisted with developing application procedures, daily program, and navigating the correctional system. This group anticipates receiving their first resident in 2021.

IN-PRISON MINISTRIES: Due to the pandemic, 9 out of 10 Prayer Conferences scheduled to be conducted within the Illinois Department of Corrections (IDOC) in 2020 were canceled, as were our regular services in Sheridan and Dixon Correctional Centers. But other avenues of ministry opened! The CEO made 54 visits with 10 individuals at the DuPage County Jail. RTO attendees signed Christmas cards for 86 inmates and 145 letters were sent. In the third and fourth quarters, we held three virtual services at Sheridan Correctional Center. This was a major accomplishment, as many security issues needed to be addressed in order to allow this kind of access. We are grateful to God and the IDOC for the opportunity to bring messages of hope during this difficult time, along with gifts of soap and bottled water. A 2020 highlight was the production of two DVDs, "Hope for Re-Entry" and "Songs of Hope," which were distributed throughout the IDOC and 18 prisons in MS and LA. The programs contain music, devotional thoughts, and a Bible-based message -- and have the potential to be seen by thousands of inmates as they are aired on the in-house systems within the various prisons.

People may serve by accompanying staff members or leading volunteers teams to minister to inmates within jails or prisons. Due to the pandemic, in FY2020, there were very limited opportunities for this type of service. Others may provide spiritual or physical aid by offering transportation, clothing, or friendship to those recently released from prison. Many volunteers perform multiple services for our weekly Radical Time Out gatherings (cooking, cleaning up, audio/visual teams, musicians, Bible teachers); however, the pandemic removed these opportunities for services in 2020. Most importantly, though, are the many volunteers who pray FOR the ministry and WITH individuals connected to the ministry. The pandemic did not stop this. In fact, it gave birth to daily virtual prayer meetings.

Form 990, Part VI, Section B, Line 11b - Process to Review Form 990: The return is prepared by KHNM's Operations Director and reviewed by the Secretary/Treasurer of the Board. After this, the return is provided to the full Board of Trustees for their review prior to its being filed with the IRS. This review typically takes place at the board's June meeting.

It is the Committee's responsibility to review the statements and take any action as may be needed.
