After this, the return is provided to the full Board of Trustees for their review prior to its being filed with the IRS. This review typically takes place at the Board's June meeting.

As we grow in understanding of God's radical love for us, we will then grow in radical love for others, including those who are incarcerated, in crisis, and/or their family members. Our board of trustees holds a monthly prayer conference call as well as regularly meeting in groups of two or three to bring ministry-related requests and praises before our Heavenly Father. A group of fathers gathers each Wednesday (in person and via teleconferencing) to pray for their children.
