Our mission is to bridge the gap between the Christian inmate and the local church by facilitating the integration of the former inmate into the church, workplace, and society through biblical discipleship.

RADICAL TIME OUT (RTO): A weekly opportunity to experience the love of Christ in action-regardless of color, class, culture, crisis, or crime. RTO is a safe and encouraging community that welcomes family members of incarcerated individuals, volunteers, former inmates, those anticipating entering a correctional facility, and anyone seeking to learn more about KHM's ministry. Together we share an evening of fellowship, prayer, testimonies, Bible teaching, and once a month a shared meal. Average weekly attendance in 2025 was 78. A major highlight of the year was the very warm reception of Wellspring Alliance Church, which generously opened its facilities for RTO and strengthened the sense of welcome and belonging for all who attend. Program offerings in 2025 included many inspiring testimonies, a Seder celebration, quarterly School of Prayer teachings, signing 112 Christmas cards for inmates with connections to RTO, and monthly meals-many of which were lovingly provided by volunteers from Gary Church in Wheaton.

COOK COUNTY JAIL (CCJ): In 2025, the CCJ ministry-led by staff and approximately 25 volunteers-conducted five weekly worship services reaching multiple tiers of men and women in Divisions 3AX, 6, 9, and 11. Volunteers shared the hope of the gospel through worship, prayer, and Bible teaching. KHM distributed 5,000 Christmas gift bags to individuals in custody and 800 special gift bags to correctional staff, each containing Scripture-based materials and practical items, extending the message of Jesus far beyond the weekly services-a 79% increase in the number of people reached compared to the prior year. A special multi-tier event with Pastor Marco David deepened the impact of this outreach, by allowing some of the men who received his book, "Collateral Blessings," to hear directly from its author. Recognizing the vital role of correctional staff, KHM also hosted four appreciation meals in the divisions we regularly serve, offering comfort and spiritual support as well delicious food. Highlights for 2025 include the resumption of women's services, the launch of a discipleship class, and the beginning of worship services in Division 9, the men's super-max security unit. Across all men's divisions, 357 men participated, with over 3,000 total attendances, averaging 70 men per week.

BUILDING BRIDGES, RESTORING HOPE: KHM seeks to build bridges and restore hope for the incarcerated, those returning home, and their families. Program expenses support activities such as assisting families of detained individuals, educating the public on the needs of people returning to society from prison, and providing pastoral care to donor families and community partners. In 2025, KHM provided prayer support and resource connections for 45 individuals and families, including guidance during court dates, surrender processes, and visitation procedures. Several RTO participants supported a man and his family during his surrender and staff helped connect them to a local church. Staff also conducted weekly Bible studies with five women, offering discipleship and encouragement. KHM participated in 17 speaking engagements across 2 organizations and 10 churches in Illinois and Pennsylvania, including a session with pastors and leaders from Madison County, IL on ministry to the incarcerated. The CEO also participated in two podcast episodes of "Entre Amigos con Gerson Garcia," providing an opportunity to proclaim the hope of Jesus Christ and share about the ministry with Spanish speakers.

In addition, about 140 volunteers assisted with the annual Christmas Gift Bag initiative for Cook County Jail. Some individuals serve in more than one capacity; therefore, the total volunteer count reflects the number of unique volunteers who contributed time during the year.

Form 990, Part III, Line 3 - The affiliated entity commonly known as Koinonia House of Wheaton ceased all operations in 2025 following the sale of its property. Additional information is included in the related program description.
